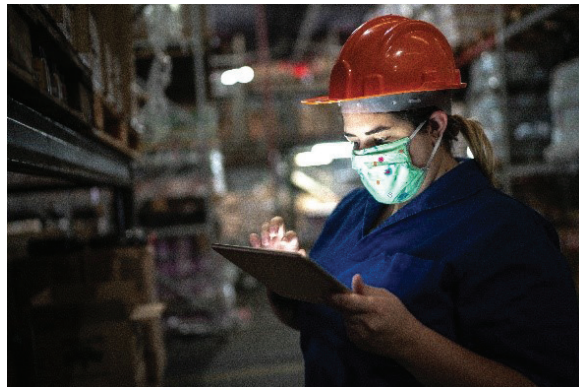
- Schedule daily, weekly, and monthly sanitization and cleaning work orders

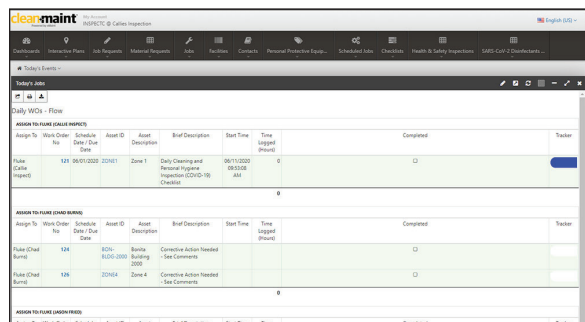

With CleanMaint, you can view up-to-date information and see multiple reports on one screen, including cleaning and sanitization status and pass/fail safety inspection results.

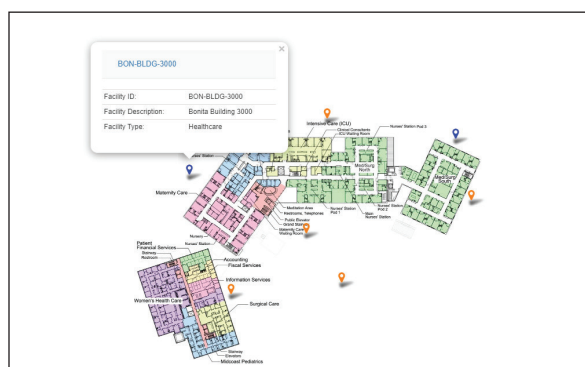


Two additional capabilities to help you accelerate your company's sanitization program:

1. Interactive maps:

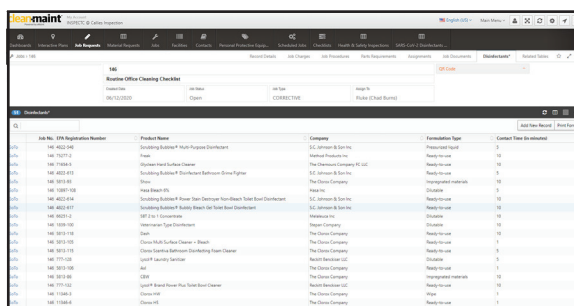
Upload a digital map of your facility and gain a comprehensive view of cleaning job progress and completions. Create zones and use colored pins to show the status of all sanitization and cleaning work.

Initially, an open WO will show as a red pin. Once the work order is complete, the pin will turn green automatically. Add blue pins if you also want to show work in progress.



2. Inventory management:

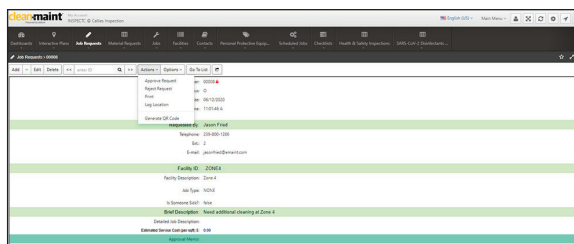
Create or update your cleaning product inventory to include essential items such as specific cleaners, disinfectants, and PPE supplies. Ensure PPE readiness by setting product thresholds and configuring the system to notify you automatically when an item needs reordering. Receive alerts when supplies reach low levels or have shortages. You can also attach helpful information to the PM, such as a list of EPA-approved products to support proper, safe sanitization.



Automatically prioritize emergency deep cleaning work requests

You can also configure CleanMaint to recognize and automatically prioritize a work request. For example, if an employee were to show signs of the virus or test positive, a deep cleaning work request would be needed. The work request could be labeled "Urgent Sanitation."

The system recognizes it as a Priority 1 and automatically generates and sends an email notification to a designated person for approval. Once approved, the rest of the workflow process continues.



Work-order fulfillment is all but guaranteed because a technician must check a custom mandatory field box before closing the WO. The approver then receives an automatic email communicating the completed work.
